Volunteer Churchill meets every second Thursday at lunch in the theatre.

Grade 12 scholarship info can be found in the D2L shell. Ms. Blackburn and Ms. Fleming can help with scholarships.

Guidance counsellors are working with the Grade 12's to help facilitate credit checks and talk about applying to post-secondary. Credit checks need to be booked and completed by December 1.

Grade 10 classes will also receive visits from the counsellors to remind them of the help available at the school and how to access.

IPP's have been sent home with students' week of September 23rd.

International Language course challenge – an email from the school will follow next week. Meeting will be held Wed Oct 2 at lunch. Grade 12's will only be able to challenge a second language course.

5. Student's Report: Lilah Perkins, grade 11 student

Fall sports are up and running. Volleyball teams are phenomenal! Girls soccer team is doing great! Cross country team is up and running. Swim tryouts are in 2 weeks. Musical will be The Adams Family and auditions are happening soon. Volunteer Churchill had a great turnout. Basketball open gyms start next week. Club fair was in the foyer this year and had a great turnout. SWC Football is undefeated this year! Winter dance will be December 4.

6. Principal's Report: Mr. Rajan

Mr. Rajan has been principal at SWC for the last 12 years and has been with CBE for over 20 years.

SWC has over 40 clubs for students to join. There are athletics and fine art clubs. Your child is encouraged to join a team or a club. Students are provided with letters from Mr. Rajan for the extra-curricular activities they participate in at school.

SWC has 2200 students and over 100 staff. Communication with the school is key. September is a very busy month at the school. 6 portables are being delivered and set up. Fire exits are being built. Next semester CTS courses (robotics, computer networking and mechatronics) will be offered for grade 10 and 11's. This course space is under construction now. The move to the portables will happen at the end of October.

Timetable changes cause disruptions at the school. SWC was projected for 2260 students for this school year. School was staffed for 2220 students in June 2024. 1990 arrived for school in September 2024. Timetables had to change as some classes had to be collapsed due to the lower than anticipated enrollment.
