   There is a school dance happening at the school tonight.
- 6. Principal's Report: Mr. Rajan
  Winter Ball is happening tonight, first school dance since COVID. Students are
  very excited. This was organized by the students. Staff are supporting the

dance. Students made about \$1000 profit. The students will be returning the \$300 that council provided to them. The remaining \$700 will be donated to the school food bank.

Wellness Symposium – leadership students presented at the CBE board meeting today

Top Dog basketball tournament will be held this weekend at SWC and there is a pep rally tomorrow

Senior girls went to volleyball provincials last weekend. There was a heavy snowfall warning and parents ended up driving their students' home and the bus came home with the teacher only on it. CBE felt the roads were too unsafe for students to come home on the bus. Parents of players made arrangements for rides and all players, parents and teachers made it safely home by 10:00pm Saturday night.

City swim championship today, results are still be tabulated, but it looks like SWC won the city meet.

Fundraisers are happening at the school and Christmas hampers are being organized. Thank you to council for your donation for the hampers. All families in need at the school will be taken care of this holiday season.

Construction downstairs is almost completed. Second semester will see 3 additional options offered in CTS programs to the grade 10's and 11's. September 2025 will see 2 additional options offered. Portable project is also ending. For second semester, the second language classes will be moving to the portables.

Extended leave policy: beyond 10 days of extended leave, teachers are not able to catch students up. This is a CBE policy. Mr. Rajan meets with any family who is looking to travel and be gone longer than 10 days. There is a time minimum requirement for students to complete high school courses. Leaves longer than 10 days are not recommended, especially in Grade 11 and 12. This can have a detrimental effect on students learning. The only exception to this is for a medical leave where a student is unable to attend school.

SWC celebrates their diversity as students come from all parts of the world. Flags were put up to celebrate where each student comes from. The Israeli flag was put up and this upset some students who asked for it to be removed. Mr. Rajan has had many conversations with students about diversity and respectful behavior. Mr. Rajan said either all the flags stay or all the flags come down, one will not be taken down only. The students decided that all the flags should stay up. The goal of the school is to have no students feel alienated. SWC is inclusive and a safe space for students.

Teachers have been asked to not assign homework over the winter break. This is a time for students and staff to relax.

Questions/Comments: are there resources available for the new CTS options? Yes, this is a government initiative, well-resourced and is well funded! The funding is guaranteed for 3 years.

Thank you for how you handled the situation with the flags. We appreciate your leadership. Thank you for making everyone feel like they belong.

CTS options Grade 11's can access grade 10 courses in second semester this year, then grade 11 classes first semester next year and grade 12 classes in second semester.
